Workshop 7. Tracking Farmland Loss In Tennessee SoBro Speaker: Charles Martinez, UT Agricultural and Resource Economics Professor

Tennessee continues to incur unprecedented growth in population, commerce, and development. A recent national analysis of the rate of farmland loss listed Tennessee as the second highest state in the nation, behind Texas, for the rate of farmland loss. Upon a further analysis conducted by the UTIA, the Institute found that when looking at the rate of "prime farmland" loss, Tennessee moves to number one. TN. Agricultural Commissioner Charlie Hatcher and leadership of the Tennessee Farm Bureau have asked TML and Tennessee County Services Assoc. for their help in identifying strategies, policies and proposals to help address the challenges facing the state's largest industry. TML members will get a first look at his analysis that is expected to be a topic of the next legislative session.
