Workshop 7. *Slum Clearance, Property Maintenance and the Administrative Hearing Officer*

Transforming Revenue Distribution in TN: Adopting Annual Population Estimates for State-Shared Revenue Allocation Speakers:

- Tim Kuhn, Director, Tennessee State Data Center, UT Boyd Center for Business and Economic Research

A new state law will require annual updates to municipal population figures, replacing the current reliance on the decennial census and optional special censuses. Beginning January 1, 2026, the University of Tennessee's Boyd Center will provide yearly population estimates to be certified and used to determine per capita tax allocations and eligibility for population-based state grants and programs. This workshop will explain how the new process works, what it means for growing and shrinking communities, and how local governments can prepare for the changes taking effect in the 2026-2027 fiscal year.

This workshop brings together experts to explore the complex and pressing issue of attainable housing through a Tennessee-centric lens. Attendees will gain insight into the current state of the housing market across the state, including key trends shaping availability and affordability. Panelists will discuss the root causes behind Tennessee's housing challenges. Participants will leave with practical strategies and policy ideas that local leaders and stakeholders to consider implementing in their own communities. Whether you're new to local government or a veteran familiar with local planning and housing issues, this session offers valuable tools and inspiration for real-world impact.

TN's Hemp Law Overhaul: What Local Officials Need to Know Speaker: Russell Thomas, Executive Director, TN Alcoholic Beverage Commission.

In response to consumer safety and legal concerns over cannabis-based products, the Tennessee General Assembly enacted sweeping reforms to its 2023 hemp statutes. Regulatory authority now resides with the Alcoholic Beverage Commission; new licensing and brand-registration requirements are in place; excise taxes must be collected; legal thresholds for intoxicating compounds have been codified; certain product categories are prohibited; and tighter controls govern sales and distribution. Meanwhile, additional bills proposing enhanced local oversight stalled at adjournment—but may resurface next session. Come learn how the law has shifted responsibilities from the Department of Agriculture to the ABC, what new paperwork and fee structures you can expect, how to spot non-compliant products or illicit sales, and when to coordinate with state regulators or prosecutors.
