# Effect of Revenue Changes Enacted 2012-2017 on Kingsport

The estimates shown are based on the Fiscal Review Committee's actual fiscal notes for the bills passed into law, and allocated proportionally based on the 2016 certified populations or 2014-2016 average Hall Income Tax proportions. These estimates do not assume any growth in the tax base; therefore, any reduction prior to 2017 may currently be higher or lower depending on the actual growth.

### Changes Prior to IMPROVE Act

#### **Reductions in Sales Tax on Food Rate**

Sales Tax on Food rate was reduced two times between 2012 and 2016. The 2012 reduction resulted in a <u>reduction in state shared sales revenues to Kingsport of \$(8,346)</u>. In 2013, the rate reduction on food <u>reduced state shared sales revenues to Kingsport of \$(11,429)</u>.

#### **Increase in Hall Income Tax Exemptions**

Hall exemptions were increased three times between 2012 and 2016. The 2012 increase from 16k/27k to 26k/37k <u>reduced Kingsport Hall revenues by \$(6,728)</u>. The 2013 increase to 33k/59k <u>reduced Kingsport revenues by an additional \$(8,737)</u>. The final increase in exemption to 37k/68k in 2015 further <u>reduced Kingsport revenues by \$(5,685)</u>.

#### Reduction in Hall Income Tax Rate

The 2016 reduction in the Hall Tax rate from 6% to 5% reduced Hall revenues to Kingsport by \$(167,656).

#### **IMPROVE** Act Changes

#### **Gasoline & Diesel Fuel Tax Revenues**

Improve Act will increase gasoline & diesel shared revenues to Kingsport by estimated \$298,196 in the first year. When fully phased in, Improve Act will <u>have increased gas/diesel to Kingsport</u> by projected total of \$500,293.

#### **Reduction in Sales Tax on Food Rate**

Enacted reduction in the state sales tax rate on food will result in an estimated reduction of  $\frac{(81,533)}{(81,533)}$  in state shared taxes to Kingsport.

#### **Phased Elimination of Hall Income Tax**

Enacted Hall phase-out will reduce Hall revenues to Kingsport by an estimated \$(199,958) in first year, \$(599,873) in first three years of phase-out and a total projected <u>reduction of \$(999,786)</u> when Hall is eliminated.

### IMPROVE Act, as Modified by Chairman Doss' Proposal

- Proposed 95-5 reallocation of the gas/diesel tax will reallocate the current fuel tax collections so that 95% of the collections assigned to cities will be distributed on a per capita basis, while 5% will be allocated so that each city receives an equal amount. <u>This change will result in a</u> <u>\$(77,615) difference to Kingsport</u>.
- Proposed increase in the "sharing percentage" of State Shared Sales Tax to cities from 3.6 to 4% will provide an estimated <u>increase of \$528,122 in state shared sales tax revenue to Kingsport</u>.
- The interaction of Chairman Doss' Proposal and the enacted Improve Act will result in an estimated net impact of \$(339,100) in funds flowing to Kingsport as compared to an estimated net impact of \$(581,026), if the Doss Proposal is not enacted.
